RECONFIRMATION INFORMATION: Your continuing or return air reservations from the following points will be cancelled unless you reconfirm at least 72 hours before your flight departure.

From Florida, Bermuda, Bahama Islands, Mexico, Puerto Rico and the Virgin Islands.

From the Continental United States or Canada—(when arriving from Bermuda, Bahama Islands, Mexico, Puerto Rico or the Virgin Islands).

Passengers on international flights must reconfirm their continuing or return reservations at each boarding point, if a stopover of 72 hours or more is made.

To reconfirm simply advise Eastern - by telephone or in person - of your intention to use your reservation.

Note: Reconfirmation is not required if your stopover at the above points is less than 72 hours.

CONNECTING INFORMATION: If you are a connecting passenger to an Eastern flight and your baggage has already been checked to your final destination, you may go directly to the boarding gate at the connecting point. You do not have to recheck at the ticket counter.
